POSTMARKS SHALL NOT GOVERN. FAX OR EMAIL SUBMISSIONS WILL NOT BE ACCEPTED.** Illegible, incomplete, or invalid filings, and any altered or changed reproductions of the Official Filing Form, will be subject to rejection, and accompanying fees will be deemed contributions to LCRC.

I am a legal and qualified voter of Loudoun County, under the laws of the Commonwealth of Virginia, who is in accord with the principles of the Republican Party, and who, if requested, will express in open meeting either orally or in writing as may be required, my intent to support all of its nominees for public office in the ensuing election.
